Settlement Proposal

Dear

In an effort to minimize litigation costs and to bring this matter to an amicable resolution, my client has authorized me to make the following settlement proposal:

- 1. Custody. The Parties shall share joint physical and legal custody of their minor children with Father having primary decision-making authority pursuant to the parties' 2019 Agreement.
- 2. Mead Hall. The minor children shall attend Mead Hall in Aiken, SC for the 2021/2022 school year. Mr. Ravenel will be responsible for all tuition fees and costs associated with the children's enrollment and attendance at Mead Hall.
- 3. *Physical Custody*. The parties shall share parenting time on an alternating weekly schedule as set forth in Article I, Paragraph B, Section 5 of the parties' 2019 Agreement.
 - 4. Summertime and Holidays. The parties shall share parenting time as set forth in Article I, Paragraph B, Section 4 and Article 1, Paragraph B, Section 6 of the parties' 2019 Agreement.
 - 5. Restraints and Miscellaneous Matters. The restraints and miscellaneous matters shall remain as set forth in Article 1, Paragraph C and Article I, Paragraph D of the parties' 2019 Agreement.

- 6. Child Support. Mr. Ravenel shall pay Ms. Dennis \$5,000.00 per month in child support payable to Ms. Dennis on the first day of each month. The provisions under Article II, Paragraph A of the parties' 2019 Agreement will no longer be applicable to Ms. Dennis.
- 7. Health Insurance and Uncovered Medicals. Mr. Ravenel shall maintain the children's health insurance and shall be solely responsible for all uncovered healthcare expenses as set forth in Article II, Paragraph D of the parties' 2019 Agreement.
 - 8. *Taxes*. The provisions of Article II, Paragraph E of the parties' 2019 Agreement shall remain in place.
- 9. Housing. Mr. Ravenel shall provide Ms. Dennis Two Hundred Fifty Thousand and 00/100 (\$250,000.00) Dollars towards a house of Ms. Dennis' choosing in the Aiken area. Ms. Dennis will have sole title to this residence. Ms. Dennis shall select a house by May 1, 2021, and closing shall occur on or before June 15, 2021.
 - 10. *Moving*. The parties' children shall relocate to Aiken, South Carolina, on a full-time basis on July 1, 2021.
 - 11. Moving Costs. Mr. Ravenel shall pay for the relocation and moving costs incurred by Ms. Dennis in moving to Aiken, South Carolina.
 - 12. *Relocation*. The parties shall revisit the decision to keep the children in the Aiken area on or before July 1, 2022, and discuss whether the children remaining in Aiken, South Carolina is in the best interest of the children based on school records, performance in school, and social interactions.
 - 13. Attorney's Fees and Costs. Mr. Ravenel's attorney shall draft the Modification Agreement and all necessary paperwork, including a Final Order, to effectuate this proposal and shall be solely responsible for the filing fee with the Charleston County Family Court.

We believe this offer is more than fair and is in the best interest of the minor children. I would appreciate your discussing this offer with your client and getting back with me at your earliest convenience.
